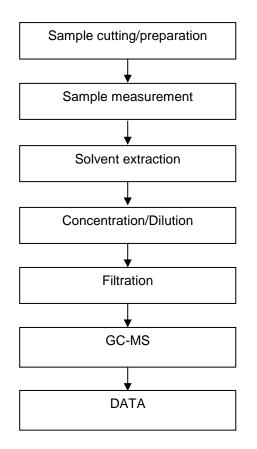


## Phthalates Testing Flow Chart

## **PBBs/PBDEs Testing Flow Chart**







These samples were dissolved totally by pre-conditioning method according to below flow chart.




